### Candidates who did not earn a passing score on the edTPA on or before June 30, 2018

These candidates must satisfy one of the following two conditions to be eligible for the edTPA safety net.

 Candidates must have a passing score on an Assessment of Teaching Skills – Written (ATS-W) that was taken on or before April 30, 2014.

OR

 Candidates must receive an edTPA score report on or before June 30, 2018 that shows they did not pass the edTPA, take an ATS-W between the date of the edTPA score report and June 30, 2018, and pass the Assessment of Teaching Skills – Written (ATS-W).
Candidates must receive the edTPA score report prior to taking an ATS-W and cannot take the ATS-W after June 30, 2018. They may receive their ATS-W score report after June 30, 2018.
